#### WHAT IS DACA?

Deferred Action for Childhood Arrivals (DACA) is a United States immigration policy that allows some undocumented immigrants who were brought as children to apply for a renewable one-year period of safety from deportation and become eligible for a work permit in the U.S.

In order to be eligible for the program, recipients cannot have felonies or serious misdemeanors on their records, must have come to the US before June 15, 2008, and must have a high school diploma.

### requirements

- Were under the age of 31 as of June 15, 2012;
- Came to the United States before reaching your 16th birthday;
- Have continuously resided in the United States since June 15, 2007, up to the present time;

- Were physically present in the United States on June 15, 2012, and at the time of making your request for consideration of deferred action with USCIS;
- Had no lawful status on June 15, 2012;
- Are currently in school,
- Have graduated or obtained a certificate of completion from high school,
- Have obtained a general education development (GED) certificate, or are an honorably discharged veteran of the Coast Guard or Armed Forces of the United States;
- Have not been convicted of a felony, or three or more other misdemeanors, and do not otherwise pose a threat to national security or public safety.

### IDENTIFICATION OPTIONS

**REAL ID:** A Real ID will be required beginning October 1, 2021, if you wish to use your driver's license or state ID card to board commercial aircraft on domestic flights. Secure federal facilities, such as military bases, already require licenses/IDs to be Real ID compliant.

DRIVER'S LICENSE: "IF U.S. IMMIGRATION DOCUMENTS ARE USED AS PROOF OF IDENTITY, THE EXPIRATION OF YOUR LICENSE WILL COINCIDE WITH THE DEPARTURE DATE ON YOUR IMMIGRATION DOCUMENTS. THESE LICENSES WILL BE MARKED "LIMITED TERM."

**SOCIAL SECURITY:** Once your DACA application has been granted and you have received your Employment Authorization Card, you're ready to apply for a Social Security Number (SSN). **call the toll-free number at 1-800-772-1213 or visit your Social Security office.**

#### JUST IN CASE YOU DON'T QUALIFY

**ITIN:** (Individual Taxpayer Identification Number) is a tax processing number only available for certain nonresident individuals who cannot get a Social Security Number. You can use the IRS's Interactive Tax Assistant tool to help determine if you should file an application to receive an Individual Taxpayer Identification Number (ITIN). <u>http://bit.ly/ITANV1</u>

#### **DRIVER AUTHORIZATION CARD -**

Nevada residents who cannot meet the proof of identity requirements for a driver's license or ID card may be able to obtain a Driver Authorization Card (DAC). These cards authorize the holder to drive a motor vehicle on Nevada public streets and highways. A DAC is not valid as identification to obtain any state benefits, licenses or services or for federal purposes such as boarding an aircraft or entering facilities where ID is required.
